

## COMBINED SHAREHOLDERS' MEETING ON JUNE 8, 2020 – HOLDING OF THE MEETING IN CLOSED SESSION

**La Plaine Saint Denis, May 4, 2020** – In the current context linked to the Coronavirus (Covid-19) and in order to respect the restrictions linked to collective gatherings and travel imposed by the Government, SRP Groupe's shareholders are informed that, in accordance with the provisions of *Ordonnance* n° 2020-321 of March 25, 2020, the Combined General Meeting (ordinary and extraordinary) will be held **exceptionally behind closed doors, excluding the physical presence of shareholders and persons who may attend**, on June 8, 2020, at 10 a.m., at 1 impasse du Pilier, 93210 La Plaine Saint-Denis..

A notice of meeting (avis de réunion), including the agenda, the draft resolutions that the Board of Directors plans to submit to a vote of shareholders, and main instructions for voting and exercising shareholder rights at the General Meeting on June 8, 2020, has been published today in the Bulletin des Annonces Légales et Obligatoires (BALO) (announcement no. 2001234).

Shareholders are invited to vote by correspondence or to give their proxy to the Chairman of the General Meeting, in accordance with the methods specified in the notice of meeting, and to privilege, where possible, electronic means of telecommunication.

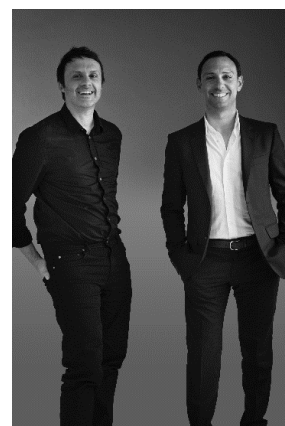
